- In general, everything is adequate, but we need more ability to interreact with others in Montville to create more community spirit.
- I hope we can return to a transfer station that provides the feel of a place to chat with neighbors and share goods (the table for leaving and taking) that we had before the pandemic. The current arrangment feels very unfriendly.
- Access to lake(s)? Share with Liberty (Marshall Shores)?
- "[re Code Enforcement: Less is more] More timely snow plowing/sanding and spring road grading would be good places to start. Currently they need improvement"
- "[re town office hours and service: just hours need improvement service OK] [re town office and transfer station in mud season: needs improvement]"
- "Animal control needs to respond to rabid animal calls. Town Hall could increase hours."
- Water quality studies and standards established for aguifers. Waldo County watershed studies
- [re liberty ambulance: Don't know and It DOES concern me]
- Concerned about town hours and town clerk services. Seems I've been there several times and the assistant cant do stuff.
- Expand the list of recyclable items that can be brought to the transfer station (e.g. Styrofoam)
- Website is a bit chaotic to navigate and has old information.
- "[Cemetery Care ""Until Halldale""] plan for wildfires in droughts more frequent"
- Healthcare is controlled by one corporate entity no maternal birthing services nearby. It is increasingly too expensive for most working age people to afford.
- Adding tax commitment and tax cards to the town website would be handy.
- We are very pleased with the road maintenance and repair + snow removal.
- Please make online vehicle registration available. Appreciate that we can go to surrounding towns but my gosh, it's the 21st Century.
- We are relatively new to the town so don't have much insight on some of the questions above.
- "Code enforcement- We shouldn't concern ourselves with codes that cannot be enforced. Ambulance services- Weed out incompetent members. I know of two instances, one in which directly effected my family, that showed how

useless they were in helping my family member and I had to take over in getting my family member out to the ambulance."

- "We have limited social transportation for medical and shopping. We have loop holes between State assistance and town assistance with those in need of both medical and adequate/safe housing. Cemetery's are falling apart faster than they can be maintained."
- Transfer station the hours are difficult for people who work, especially in the winter. There needs to be more than one rolloff day. If you drive through town there is junk in many yards. If you can't get to the rolloff the weekend after Independence Day then you need to keep everything for another year. Also, if you do any renovations or cleaning/decluttering after Independence Day you have no way of disposing of it. Frequently, the wait time in line is also unacceptable. We used to have two rolloff days per year. We'd love to see three or four.
- Montville is not the place you chose to live in if you want lots of Town Services.
- The town should partner with the Town of Liberty for fire protection sevice. Combining resources would be more efficient for both towns financially and functionally.
- No additional services that would require taxes to increase.
- Does the town provide transportation to those without? When one googles the town of Montville the phone number is incorrect. Found out we are now on an online phone system and there is no way to get the google website off even tho it's confusing folks. Someone must know how to do it.
- Everything is going well.
- Better Animal Control with actual investigations
- Would love to see curbside recycling and trash pick-up.
- "I'm not sure if the Town should feel responsible for all this, health care for example."
- "There are no parks in the town for children and outdoor recreation areas are not well marked or advertised. Until this survey I was unaware that the Library in Liberty is shared and accessible to Montville residents. I have serious concerns about the response times to emergencies. I know the departments are doing the best they can with what we have but we need more people trained to operate an ambulance and we need to be able to respond faster. We need support with trash disposal for large items like furniture, or appliances. We need access to a large dumpster more often. Other towns like Belfast do not allow outsiders to use the dump and it causes trash accumulation. There needs to be an easily accessible list of what things can be done at the Liberty town office to offset the hours when our town office is closed. The town website is not user friendly, especially on a mobile device. "
- Welcome to Montville what the town hall provides (Lots!); where the library (Liberty) and post offices are (Freedom for pickups and holds); history and current events i.e. I don't know anything about general assistance that's available
- I don't like that the last option on a number of questions was "I don't know/Doesn't concern me". "Concern" as in doesn't involve me or I'm not worried about it? There's several where I don't know, but it was of concern or potentially applicable.
- Why doesn't Montville have an arrangement to dispose of large trash items during the year. One or two days a year
  is laughable. How much junk is in the woods or people's yards as a result? Other small towns nearby have methods
  for disposal during the year. We're probably losing potential revenue as well as creating dumping areas where they
  shouldn't be.
- "Terrible option: "Don't Know/Doesn't Concern Me." Those are two very different response options. Most of these service areas, I don't know. However, if they assist or are important to residents who are in need of them, then I would share concern about them."

# Q8: HOUSING: What do you see as unmet housing needs in Montville? Please provide additional comments on housing in Montville below.

I wonder how financing can be arranged to build higher density units or complexes of really small homes arranged well. But in Palermo near Tobey's, not here. More residents means higher education costs.
- nothing affordable. I worry about substandard or non-existent septic systems especially for tiny houses and campers
- I suspect, as is true with most towns, we could use more low income housing options.
- With no zoning in place not too many want to build a new house of any sizable size if there's going to be a trailer next to them or having someone that trashes his or her yard with junk or abandoned autos. There investment in a nice house takes a big hit. Also having little make shift housing doesn't add to the tax base but does more to discourage new construction.

- What are our realistic options?
- The highway department has been largely unresponsive in our interactions with them so far. The planning for paving and culvert work seems uncoordinated.
- Town has to much work for our regular maintenance like maintaining ditches and culverts, mowing roadsides and plowing with a small town crew. Contracting out for specific jobs like culverts, snowplowing, and mowing roadsides/ditches seems to work.
- By whomever does the best job and for a decent price. The cheapest is not always to most cost effective.
- In the past, roads have been improved to meet individual trucking company needs with no input from home-owners. Homeowners need more input. The road in front of our house has been raised almost 5 feet over the years, drainage ditches are dangerous, and speeds have increased. Yes, roads need care - but need more community input.
- The town's roads are in a deplorable condition, with no apparent plan for maintenance or improvement. Dirt roads are sorely in need of proper crowning and ditching. The town of Freedom seems to know how to maintain their dirt roads; our roads department should seek advice/training from them.
- I would not want a competitive bid process to be the sole caretaker of roads. Sometimes a higher bid by a more reputable individual would be better than a lower bid. Regarding town and town equipment vs contractor, I would leave that up to others, as I don't know the challenges in this area.

- We think the town does a great job, but there might be too many roads to keep up with sometimes.

# Q11: ROADS/TRANSPORTATION: Would you potentially support paving certain vulnerable sections of roadway in Montville if it helped to decrease maintenance costs?

- Yes, this seems obvious.
- Need to know to what extent paving could decrease maintenance costs.

- Make roads sounder
- It depends paved roads equals speeding
- Important to keep paved roads first priority for safety improve gravel roads as can be affordable
- Look at tar & chip as a less expensive maintenance option vs. paving for roads with less trraffic.
- I prefer to live on a dirt road but realize it may not always be that way
- I would not want to see dirt roads paved
- Only if it reduces maintenance costs
- I guess we would need more information to make the decision.
- Need more details
- "Paving is fine for steep sections. I would also pave dirt roads for 100-200' where they join any main paved road.
   Main issue is that roads are becoming to wide and flat. They need to be crowned more to prevent runoff of materials into ditches. Current road commissioner doesn't seem to be able accomplish this. Maybe it would be worth contracting out a few dirt roads to a outside contractor to see if this is achievable."
- We feel some of the roads that have issues have not been properly maintained in the past so we are just throwing our money away. The most used roads should fixed properly, then the lesser used roads, unless there is a safety concern.
- Not by increasing taxes.
- I am generally for keeping dirt roads, but any change would need home-owners input
- Most of the roads subject to washout have already been paved. Proper crowning and ditching is a more viable solution.
- We have mixed feelings about that. Gravel roads are a critical feature of a rural town, but they can be hard to maintain.
- I would prefer to keep Halldale Rd, the portion I live on, as a dirt road. Mostly to limit usage and speed of travel.
- What makes anyone believe we have or could affordably hire the expertise to maintain paved roads? The people who ask for paving always appear to believe you pave and you're done. That is not the case.
- Concerned about preserving the rurual character, and preventing abusive driving practices, such as speeding, if certain roads are paved.
- When I was Chairman of a previous Comp Plan Committee one of the few things we agreed upon was that gravel roads should be paved ONLY when maintaining the gravel was more costly than paving.
- Montville has voted and raised funds to pave the mid section of Halldale Rd. Twice. I was at both regular town
  meetings. I do support selective paving, but a few vocal people cannot be allowed to continue to overrule the will of
  Town Meeting decisions
- YES, YES price of asphalt is low now. Liberty town leaders are paving all roads as they think long-term maintenance costs will be lower. I think Choate, North Ridge Rd, Halldale and Burnham Hill Rd might be cheaper to maintain as paved roads.
- Also #10 is worded weird. Yes I live on a gravel OR dirt road (as does everyone)... In truth I'm on the corner of a
  gravel and dirt road, but the questions isn't worded clearly
- I'd rather raise taxes than pave roads, but I think there are other options too, like working together with other towns on sharing resources for road work.

# Q12: ROADS/TRANSPORTATION: Please provide additional comments on road maintenance or transportation issues below.

- I love walking on the roads and some land owners post these discontinued road beds through their property. That's a bummer. It's not MAINE.
- Just do a job
- Morse road is dismal
- The problem is NOT that our dirt-gravel roads need paving or improvement. The problem is that people are driving TOO FAST on our dirt-gravel roads. Slow down, folks!
- "Love love love the work done on the roads this summer, especially where Center road meets 220. the potholes cause a lot of car damage. thank you!!! And, it's frustrating that when roads are paved and re-paved, speeds increase so much! maybe more singposts on speed limits? I also think temporary electronic speed signs help people slow down a bit."
- Too much speeding on RT 220.
- Clumps of leaves build up in the ditches are a big issue and cause a lot of dirt road erosion as water jumps out of the ditches and quickly erodes the road surface. Can't this be addressed somehow?
- Our gravels roads have improved exponentially over the last several years!
- Some very heavily housed portions w/major blind intersections should have slower speeds posted.Unfortunately it is 220 + the states domain.
- Sand is more like gravel and makes a mess. Use better "sand".
- Bridges
- I don't find there to be any issues.
- regarding Winter snow and ice: Too much sand is dumped on the roads and often no "second Attempt" is made to clean off the slush (that is likely to freeze).
- "[re winter snow/ice removal: Not timely] Inconsistent and selective speed limit posting. 25, with four signs, on Burnham Hill Road and none on any other dirt road? Post all dirt roads the scene 30 to 35MPH"
- [re speeding: on 220]
- [re flooding: Rt 220]
- Paving paves the way for speeders.
- It is good to see the current improvement of the paved roads in Montville. Gravel roads are passable for many well traveled areas.
- I understand road maintenance is a large and difficult task, but I feel more resources should be spend on it over items.
- Might need to discontinue some roads and maintain the roads we have. Why didn't hall thou get paved all the way to Littlefield Hill? they were right there.
- Just do the job!
- We live on the Morrill Rd. Traffic used to be sparse, but has increased, and some people fly by at >75 MPH. I suspect some, though not all, are on their way to shift work at the ridge.
- It has improved very much in the last few years!
- Snow and road maintenance has improved over the last few ~ years needs to continue to improve.
- While I'm in support of basic road maintenance, I'm not in favor of paving over our much loved dirt and gravel roads. I am NOT in favor of street lights similar to what some of our neighboring towns have been installing. I want to continue to enjoy our dark skies at night.
- This question is posed like there is NO other road issues in town besides gravel roads. Bridges are not even mentioned here...

- I have felt that road maintenance has been good since we purchased our land. Snow removal has been great and routine maintenance done in a timely fashion.
- Some plowers take great pride in doing things well, others not so much. I've watched the person who typically plows 220 in Knox on the top of the ridge at Hilltop. THAT person does it beautifully and will skill and precision which is commendable. Instead of a hack-job of plowing and dumping ridiculous amount of sand and salt: sometimes too little, sometime WAY WAY WAY too much, why not invest in finding someone who just does it well and pay them well and let that be what they do and be appreciated for that.
- My observation / thought is that a couple loads of gravel, proper grading so there is a crown, packing well, and make sure the water, as it starts its descent down a hill, is directed into operating ditches would save money and hassle in the long run. I am puzzled every time I see the water at the top of our road hill running down the road instead of into the ditch. I could do it myself for cripes sake.
- transportation options are important but I don't see that as being a reasonable request for the town to address. Should be a state issue
- I have no concerns
- "State Route 220 needs to be addressed at Frye Mt. to allieviate regular flooding. This is avoidable but the town has to push the State to raise the road level. Shoulders on Rt.220 would encourage bike riding. Hidden Valley Road/Kingdom road is chained and gated but it is legally not closed to the public. This restricts walking, biking, etc. "
- Roadside mowing should be completed a minimum of once a year. The town should be monitoring and spreading calcium during the dry season to control dust. This practice seems to have been abandoned.
- I find the speeding and distracted driving to make walking the roadways dangerous.
- Discontinued roads should maintane public access.
- There must be elder and low income folks that can use help with transportation beyond WCAP. One can become isolated in rural Montville.
- It's really difficult to continue paying taxes when our road is not being maintained and a neighbor has to fill the potholes. I think overall there has been a lot of time and maintenance put into Montville's roads, especially such a large geographical area, but others get forgotten along the way.
- Maintenance of the dirt portion of Halldale Rd has resulted in the road becoming ever wider, thereby impacting the bordering lands. With all due respect, and I mean that sincerely, the road seems wider than a state route!! What is wrong with a narrower, normal dirt road?
- I'm not sure how some roads became part of "associations", but to pay taxes and not have our road maintained/plowed doesn't seem fair.
- "1. My impression is that every day is a new day for the road braintrust. A project will start and then will be interrupted for a week or a month or a year and then start up again. 2. With more winter rain occurring, the following will help the dirt roads from washing out: Open up culverts when there is snow ion the ground and rain in the immediate forecast"
- There are not many roads I feel safe walking down because of the traffic and rates of speed forcing this feeling of having to travel to other towns to get outdoor recreation access.
- Roads need to graded regularly (monthly), not only after big divots appear. It's unwelcoming to visitors and prospective owners to have to slalom across the roads to minimize damage.
- "We have several dangerous intersections. The worse is where Rte 220, Halldale Road and Freedom Pond Road meet."
- The intersection of Route 220, the south end of Freedom Pond Road and the north end of Halldale Road needs either
  a light or 4-way stop sign. There have been too many bad accidents there. A number of vehicles have been totaled.
  To my knowledge, no one has died yet, but it seems like that's what it will take and we shouldn't have to wait for
  that.
- Transportation options outside of town are inadequate, but that is not necessarily a Montville issue to solve. Perhaps the County officials could figure it out.

- Can't open windows due to blowing dust all Summer. Needs calcium applied. Why do I have to call every year?! Dump trucks are up & down Spring Hill Road all Summer & it's a dead end.
- "A little attention can prevent serious erosion. The grader should always grade out to the edge of the road. The worst damage has happened when the grader pushed gravel down a hill to fill potholes at the bottom and left an ungraded curb-like barrier on the edge of the road that prevents water from running off the side into the ditch."
- The Select board needs to grow some stones and tell the State DOT if they can't maintain 220 better then Montville will cease winter road maintenance and return it to DOT, the slight loss of funds would far exceed trying to keep that stretch clear in winter. If they had to plow it it would look like the road going by Mt. View that they maintain winter and summer
- "Why are we paying for road maintenance on the Howard rd with two houses? It's more like paying for someone's driveway as far as town use goes. How many other roads need to not be maintained or plowed?"

# Q13: RECREATION: Where would you like to see additional or improved public access to outdoor recreation opportunities in Montville (ie trails, forests, or waterbodies)?

#### Q14: RECREATION: Are you concerned about traditional access to private lands being restricted?

- I haven't seen an overabundance of posted signs but I'm not a hunter. Still we've got mant hiking trails and snowmobile trails.
- Lots of development. I've seen in just last 10 years. More people post undeveloped woodland/paths. Maine law protects landowners from many liabilities but people don't always know that and may post to avoid lawsuits. Some owners restrict machines or hunting but may just exclude everyone. It's getting fatiguing taking all posting seriously. It's over applied.
- I would need to know more about this issue to comment. I believe that hunting access should be able to be not allowed by private owners, but I wonder about other kinds of foraging access being made easier, or even crossing over private land while exploring/hiking?
- The landowner can manage their private land as they see fit.
- It seems like more new landowners are posting their properties where before there had been an understanding of having designated access on private lands. Perhaps, there could be a Town conversation to work with landowners in opening specific areas.
- Education to new LOs re: Maine traditional land access vs posting. Too many people from away are posting their
- across from Northridge Rd near bottom of hill.
- Private property should be respected, and the rights of property owners should come first.
- Private landowners have the right to keep their land private if they wish.
- Common use of lands is a long Maine tradition
- At this time our town has reasonable access to natural areas given general attitudes of land owners; population growth may require a more structured consideration.

- Can't be specific at the moment, however, I grew up in N. Maine where walking on someone's acreage was never an issue (not including hunting). I feel that land-owners have become more territorial and probably in Aroostock Co. as well.
- I call my road the "Yellow Sign" Road! It was extremely rare to see posted land when I was young.
- Having access to our natural recreational areas is important to our health and lifestyle up here. I feel strongly that there should be negotiated right of ways to all our ponds, trails and wooded areas.
- Town should ask and get permission from land owners.

- Closure of long used hiking trails by private individuals for unknown (or dubious) reasons, frankly, sucks. Posting of historic rights-of-ways on the property boundary tree line (line trees) seems legally questionable.
- I do not understand the question. It is too vague.
- More land is being posted. Maybe we need to distinguish access via foot vs. motorized.
- We restrict our land due to our management plan and our land use. Also, the few times others have used our land most have left trash and not been respectful. Even though our land is posted we've had several instances of trespassing, including motorized vehicles tearing up our fields.
- Private land is private and access is up to the landowner.
- It depends... I wouldn't want people tromping through my front yard but private land for fishing etc ok if no homes or privacy is not disturbed
- Private land owners should get to decide.
- Only if people don't understand the nature of the trail systems and that it doesn't lead to land trusts claiming ownership. And if Sunday hunting ever makes it through the legislature successfully, that will likely limit access.
- If people behaved on my land, I would let them use it. They don't, so I don't. IDk how you reinstate, much less control, consideration for others in our current environment and with current attitudes by many.

### Q17: NATURAL RESOURCES: How do you think the town should protect natural resources? Select all that apply.

- I don't know what the best mechanism is. It's a tough one.
- We would like to see more aggressive trimming along the shoulders of the roads. Widen! Closer! More Often! Looks nice when it's done well. Not so nice when it's done half heartedly which is what we see!
- Enforce existing regulations
- grants from private sources
- [under "Implementing Protections..." Who knows what this is?
- Enforce a junkyard ordinance, offer tax incentives and grant \$ to upgrade, likely failed, old septic systems.
- Identify critical habitat and take actions above to encourage protection.
- "Land owners have diverse priorities for land use, and they evaluate resources individually and differently, and commercial laws also factor in. If tax incentives are considered to protect natural resource, to reduce taxes for land owners in Montville, then may the tax savings be precisely based on the natural resources contained in the land. For lack of exacting standards of evaluation of how much natural resource is in fact protected, we can still just evaluate ""tree growth"", for instance. For smaller land owners we could count the number of trees of a certain size, and larger land owners would also have the estimated averages of tree-acres, or perhaps even qualitative pastures. Ponds, streams, lawns and private gardens we might disregard unless and until the ""tree growth"" incentives are more clearly appreciated by all, including those who have other land uses which are protected by commercial law. Fairness is deserved by all land owners, and such big changes in municipalities need time to study and to develop properly. Best land use conservation is open for dialogs and there are even disagreements on best forest practices, even among knowledgable people. This topic could be expanded and discussed in a moderated Montville forum, so that fairness for all tax payers is reasoned out, and our community can develop peacefully."
- I'm not sure. Whatever is most effective and ethical.
- Get state support for management and protection of these areas
- Partner with organizations like St. George's land trust (Haystack mountain) and Midcoast conservancy (Sheepscot) let them speak at town meeting!

- The state of Maine like many rural poor states undervalue education and teachers. And, of course, education funding is certainly lacking and unsupported at the federal level.

- Providing a financial support to families who are interested in having their children attend schools in othe districts rather than having all our educational taxes go to RSU#3
- Schools can always be better, but feel there are socio-economic issues that weigh down the students in the area. Stronger families deciding to remove their children from the schools continues to weaken the community, versus growing and nurturing our community as a whole.

  significant increase to RSU3 while the education is lacking and children are graduating without being able to pass
  entrance exams for college.
- The closing of Walker School was a major blow to our community. Creating a local school that caters to the needs and ideals of our families would surely benefit the whole community.
